- Films must be suitable for screening to a PG Audience.
- Entry must be submitted in a DVD format.
- Please include with your entry, if possible, film stills, director/producer bios (this may be submitted on a disc).
- Entries will not be returned.
- Entries to the California Surf Festival are at no charge for the "Hot Grom Shorts" Film Contest.
- Filmmaker must have model's releases and rights from persons featured in film.
- Filmmaker must indemnify and hold California Surf Museum, CSF, and its Sponsors, harmless from and against any liability that may arise from showing film.
- Minor Filmmaker's parent or legal guardian must sign and join in indemnification.

As an inducement to the California Surf Museum to consider its entry, by signing this form, the person submitting the entry to the California Surf Festival ("CSF") and, jointly and severally, the person's parent or legally appointed guardian if the person submitting the entry is a minor (jointly and severally "Entrant"), represent(s) as follows:

1. Entrant has received and holds valid and enforceable written model's releases and permission to use and display all of the content of the entry in the CSF.
2. Entrant hereby consents to California Surf Museum showing the entry in the CSF and, in connection therewith, hereby agrees to indemnify and hold the California Surf Museum, the CSF, and its Sponsors, harmless from and against any and all liability arising in any fashion from showing the entry in the CSF.
3. Entrant hereby represents that Entrant holds all necessary rights for the submission of the entry and granting of rights to the CSF, and agree(s) to observe all of the Festival Guidelines and Regulations.
4. Submission of an entry in the CSF shall constitute agreement with the CSF and its guidelines.
5. Entrant must provide proof of age by submission of photocopy of valid State-issued identification acceptable to the California Surf Museum and the CSF.
6. Any Entrant who cannot provide proof of majority in accordance with the foregoing, must have Parent or Legal Guardian sign form, and Parent or Legal Guardian must prove their identity (and Legal Guardianship, if claimed) by submission of photocopy of valid State-issued identification (and Guardianship documentation, if relevant) acceptable to the California Surf Museum, the CSF, and its Sponsors.

AS AN INDUCEMENT TO PERMIT ENTRY IN THE CSF, THE UNDERSIGNED HEREBY AGREE WITH THE FOREGOING AND THE INDEMNIFICATION AND HOLD HARMLESS PROVISIONS IN THEIR ENTIRETY.
